of a loved one, or to recognize your generous contribution and support of the Caswell House. **The total amount of your donation is tax deductible.**

This is a perpetual project and pavers will be installed in rounds. This initial purchase opportunity offers exclusive placement in the front walkway of the house. To compliment the house, the pavers will be made of white clay and feature a blue glaze. Pavers are available in three sizes, 4x8 inches, 8x8 inches, and 8x16 inches. Aside from the general area of installation for each phase, no preference will be given to the location of pavers.

The Austin Junior Forum, Inc. (AJF) is a 501 (c) (3) non-profit women's organization committed to supporting the Austin community and enrich the lives of those in need. We focus our grant money toward agencies that serve women and children. Race is not a determining factor. Our main fund-raising activity is Christmas at Caswell in November. We also provide thousands of teddy bears and Dalmatians to the Austin area Fire, Police and EMS departments. They use these stuffed animals to calm children in crisis situations. AJF was founded in 1969 and has given over \$1.3 million dollars given to the Austin Community through grants. In addition, over 18,000 volunteer hours were served in 2005-2006. Currently, AJF has over 150 active members and 140 sustaining members. We are working women, stay at home moms, business owners, and professional volunteers who want to make a difference in our world – one life at a time. We are the proud owners of the Daniel H.
